

END USER LICENSE AGREEMENT (EULA)

This End User License Agreement (the "Agreement") is a legal contract between you (the "Licensee") and Charlemagne Music (the "Licensor") governing the use of any music produced by Charlemagne Music. By accessing, downloading, or using any music produced by Charlemagne Music, you agree to be bound by the terms and conditions of this Agreement.
